

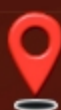

# AWARDS GUIDELINES & EVALUATION PROCESS

## APPLICATION SUBMISSION

Applications are submitted as per prescribed format and guidelines



## INITIAL SCREENING

The team from the Secretariat will go through the applications.



## DETAILED EVALUATION / SCRUTINY BY SCRUTINIZING COMMITTEE

After receiving the applications, the Scrutinizing Committee members will scrutinize them. This team will clarify all doubts and, if required, may ask applicants to make a presentation.



## RECOMMENDATIONS BY SCRUTINIZING COMMITTEE

The Scrutinizing Committee will make suggestions and provide its recommendations to the full Awards Selection Committee. The full Awards Selection Committee may or may not accept the suggestions/recommendations provided by the Scrutinizing Committee.



## FINAL REVIEW BY AWARDS SELECTION COMMITTEE

The Awards Selection Committee will make its recommendations to the Executive Committee of the ICC.



## FINAL DECISION

The decision of the Executive Committee on the Awards will be final, and no correspondence will be entertained by the ICC thereafter regarding the Awards/Citations on which decisions have been announced.




## ANNOUNCEMENT


Winners are announced; decisions are final and binding

### PLEASE NOTE:

- ICC will not consider nominations from previous ICC Award winners in the same category for a period of three years. However, companies that have received a Certificate of Merit in the past three years remain eligible to submit nominations.

## GUIDELINES & REQUIREMENTS FOR SUBMISSION OF NOMINATIONS




### SUBMISSION OF NOMINATIONS

The nomination, clearly **mentioning the category** under which it is submitted, together with enclosures thereto (if any), should be **submitted in soft copies, i.e., via e-mail to ICC Mumbai at [iccmumbai@iccmil.in](mailto:iccmumbai@iccmil.in)**, through a link, via WeTransfer, or as an attachment.



### FORMAT OF SUBMISSION

The duly filled nomination form should be sent in **DOC/PDF format**. **PPT versions will not be accepted.**



### FINANCIAL DOCUMENTS

Along with the nominations, a **one-page financial result** (Profit & Loss Statement and Balance Sheet) of the company for the year 2024-25 needs to be submitted.



### COMPLETENESS OF INFORMATION

Applicants are expected to **provide only the relevant information** as prescribed. Sketchy information will result in disqualification, which may please be noted.



### VERIFICATION REQUIREMENT

The duly filled nomination form **should be verified by a senior official** of the company (e.g., Plant Head / General Manager / Vice President or above level).



### PRESCRIBED FORMAT COMPLIANCE

Nominations should be submitted strictly in the prescribed format as per the rules & regulations governing the ICC Awards.



### EXECUTIVE SUMMARY REQUIREMENTS

Applicants should provide an Executive Summary with the following criteria:

- Maximum 500-word summary justifying the Award applied for, including graphics or pictorial illustrations (if any)**
- Justification should include key achievements specific to the Award, benchmarks carried out (if any), investments made, etc.**
