

Memorandum of Understanding Between



INDIAN CHEMICAL COUNCIL (ICC) and CHEMICAL DISTRIBUTION INSTITUTE (CDI)

This Memorandum of Understanding (MoU) is entered in to 30th day of September 2010 between Indian Chemical Council (ICC) and Chemical Distribution Institute (CDI).

INDIAN CHEMICAL COUNCIL (ICC), a non-profit making organization and is in existence under the laws of India, with its principal office at Sir Vithaldas Chambers, 16 Mumbai Samachar Marg., Mumbai 400 023, duly represented by H. S. Karangle, Director General, (hereinafter referred to as "ICC"); and

CHEMICAL DISTRIBUTION INSTITUTE (CDI), a non-profit chemical industry association existing under the laws of The Netherlands, with its principal office at Surrey, England, duly represented by Mr. Martin A Whittle, General Manager, (hereinafter referred to as "CDI").

Whereas, ICC and CDI would like to examine a possible future co-operation between themselves in the fields of safety, security and quality performance of marine transportation and storage for the chemical industry.

NOW, THEREFORE, the Two Parties confirm their mutual intent and agree as follows:

Terms and Goals of this Agreement:

- 1. To collaborate between the two associations on organizing education/awareness programs aimed to improve safety, security and quality performance of marine transportation and storage for the chemical industry in India.
- 2. To collaborate in publishing perspective report/studies on Responsible Care in the Supply-chain industries within India.
- 3. To work in close cooperation with the industry in India and promote development of best practice in marine transportation and storage of chemical products.
- To share information on industry best practice and international legislation for marine transportation and storage of chemical products to the ICC members and stakeholders.
- 5. To share current and future international legislation and knowledge about the chemical and distribution industries.
- 6. To share cost effective systems for risk assessment and promoting commitment to Responsible Care with focus on Code of Distribution Management Practice.
- 7. To share, under individual agreement, reliable and consistent inspection data for the chemical companies of India to use with confidence.

8. To support the chemical industry of India with training, qualification and accreditation where ever required.

The MOU will be implemented on the basis of friendly discussion and mutual verbal agreement.
