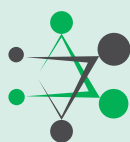

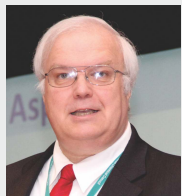




Summit Speakers

Mr. Daniel Roczniak

Senior Director, Responsible Care® at American Chemistry Council



During his 20 years with ACC, Daniel Roczniak has assisted ACC member and partner companies in the implementation of the Responsible Care® initiative in their operations. Currently, he manages ACC's Responsible Care third-party certification process. In addition to the ACC's certification program, Daniel manages implementation of the ACC's Responsible Care Security Code. Since 2010 Daniel has been working with the Indian Chemical Council to enhance its existing Responsible Care® program. Prior to his work in India, he led ACC's assistance efforts to the Dubai-based Gulf Petrochemicals and Chemicals Association (GPCA) as it launched its Responsible Care® program. Daniel is active in the International Council of Chemical Associations' (ICCA) Responsible Care® Leadership Group and has organized industry workshops and other events in South America, the Middle East and Asia. Daniel is a graduate of The George Washington University in Washington, D.C. and lives in Virginia with his wife and two sons.

Mr. Peter Newport

Chief Executive Officer, Chemical Business Association U.K.



Mr. Peter Newport is the Chief Executive Officer of the Chemical Business Association based in Crewe Cheshire, U.K., representing chemical distributors and supply chain carriers and warehouse keepers. He has been involved in domestic counter terrorism industry work for 25 years. After joining the CBA from industry in 2001, he helped develop the United Nations' chemical transport security provisions for the U.K. government and subsequently led the development of joint industry guidance on chemical transport security for both the UK and was a member of the team for the EU edition. He is a member of the U.K. Industry Advisory Group on Chemical Transport Security, the EU Advisory Group on Chemical, Biological, Radiological, Nuclear and Explosives (CBRNE), and EU Chemicals Sub-Group. Peter has contributed to two EU reviews of the chemical transport security provisions and is a regular speaker at chemical security events including Interpol's Chemex, World Customs Organization's Global Shield Program, and the U.S Department of State's CSP workshops. Peter has a Diploma in Management Studies, is a Fellow of the Chartered Institute of Logistics and Transport and a Member of the Chartered Institute of Management.

Ms. Susan Caskey

Principal Member of the Technical Staff, Sandia National Laboratories, USA



Susan Caskey is a project lead for multiple risk and decision analysis efforts within the chemical, radiological, and biological portfolio. Additionally, Susan is the project lead for threat reduction activities in multiple countries and provides mentorship and guidance to others within the threat reduction areas. Susan has a degree in biology with a minor in computer science and specializes in information management and security. She is also certified in network security architecture. Susan designs methodologies for performing risk assessments and conducts assessments of biological and chemical agents and facilities. She provides a wide range of trainings in biosafety, biosecurity, chemical security, information security and chem/bio threat reduction. Susan has also developed several models for relatively quantifying risk, including laboratory biosafety and biosecurity models, global biological/chemical/nuclear acquisition potential models, chemical security models, and models for use in highlighting abnormal disease trends. Susan is a member of the Society for Risk Analysts.
